Each period, system creates a set of names based on its ideology and spirituality, culture, mode of production, economic activity and other political, economic and social factors, and in their geographical names are sealed events related to the spirit of the development of human society, life and culture. the rest [3]. In other words, geographical names are an integral part of our spirituality, and spirituality has always been the greatest wealth for mankind [5].

Although the toponymy of the Uzbek language is well developed in our country, the toponymy of all regions of the republic, including Surkhandarya region, has not been studied geographically [7].

Migration names are the transfer of geographical names from one region to another, a process that occurs in two ways.

1. As a result of population migration, old names are moved directly to new places. For example, on the American continent there are many place names copied from Europe.
2. Names derived from the resemblance of one region to another. For example, the name of the country Venezuela means little Venice [6].

The emergence of migration names in Surkhandarya region is associated with the first way [12]. There are several migration names in the area, almost all of which are settlements of people who were relocated from Andijan in the 30s and 40s of the last century to develop the reserves of Denau and Sariosiya districts. For example, the villages of Andijan and Margilan are based on the region from which the population comes. The village of Kokand in Shurchi district is also named after the peasants who came from Kokand in the mid-1930s to explore the middle reaches of the Surkhandarya [9]. There is a place called Garden Samarkand in Dashnobot village assembly of Sariosiyo district. The name is derived from the Persian language and means garden + i + Samarkand — that is, the garden of the people of Samarkand, the garden built by the settlers from Samarkand [11].

**Conclusion.** In conclusion, we can see that such place names occur as a result of the migration of people from one area to another, depending on the historical, socio-economic, cultural and transport, geographical location.
