The first direction is to ensure the inevitability of punishment of perpetrators, and the second direction is the prevention of crime. that is, it serves to eliminate the cause of corruption, while punishment only serves to eliminate the consequence. As long as there is a cause, the consequence will always exist.<sup>5</sup> It should be noted that today corruption is not completely eradicated in any field, and government agencies and agencies are fighting it.
